It is further noted that the scrutiny of remaining applications demand further examination about the eligibility criterion. Therefore these cases will be finalised at a later date by the committee.

The Board of Directors in its meeting on 10.4.2008 discussed about the Hon'ble APCT orders and resolved that in view of the Hon'ble APCT's interim directions dt 8.4.2008 the Board of Directors is not in a position to consider the pending applications as well as the request for fresh admissions until the O P No 18 of 2008 is disposed off finally. The interim order is being extended from time to time.

In view of the above circumstances it is resolved to inform the Hon'ble High Court about the legal position on membership and seek clarification.

Subject 2 : Payment of interest to members on the initial deposits collected

Resolution 2: Responding to the request of the Board of directors, some members paid the initial deposit which was deposited in the bank as per the resolution 2 of the board of directors meeting held on 07.05.2008.
