
The BoD discussed and approved the following agenda

Subject 2: Recording the efforts made by BoD in demolishing the shed constructed in land allotted to the society and pursuing legal fight against the encroacher Resolution 2: A family of three brothers constructed a shed in Nizampet land and CEO Vamsi and Vice President Palle Revi rushed to the spot and got it demolished on April 19. The family of three brothers went to Hon'ble High Court and obtained a status quo order on April 26. They claimed that they were granted Lavoni patta way back in 1960. The Hon'ble judge made a clear mention in the order that there is a shed in existence, and it has to be protected and they should not be dispossessed from the peaceful possession of three acres. We are not made parties in the case. Taking advantage of the order they reconstructed the shed. Vamsi, Kranti and Ramesh

Vaitla met Cyberabad Commissioner and later lodged a complaint with police and an



FIR was booked against the other party for trespassing into our land and constructing the fence.

Meanwhile, the court material of a 2014 order obtained by the same parties were taken from court and found that they forged the patta certificate. The one submitted by them in 2014 is different to the one submitted in 2021. We again filed a fresh complaint with police to alter sections to forgery and cheating.

We also filed an implead petition before the Hon'ble High Court seeking quashing of April 26th order. We also brought to the court's notice about the perjury committed by the encroacher. We are waiting for the listing of the case.

The General Body of the Jawaharlal Nehru Journalists Mutually Aided Cooperative Housing Society was held at the above avenue and approved the following agenda.

Subject 1: Condolences to members who passed away and reiterating the society's resolve to extend the benefit to the nominee/legal heirs of the deceased members who paid the initial land cost of Rs 2 lakh. The GB approved the change of address from Press Club, Basheer Bagh, to Sy No 332, Nizampet, Hyderabad with immediate effect.

Subject 4: Construction of compound wall covering 32 acres allotted to the society in Nizampet and collecting funds from the members

Resolution 4: The CEO brought to the notice of the members about repeated attempts of anti social elements and land grabbers to grab land allotted to the society and stressed the need for constructing a compound wall to protect the prime land. However, majority members expressed inability to remit even small amount due to post Covid 19 financial restraints faced by them.

It was resolved to step up the guard and wait till the financial situation of members is improved

Subject 5: Possession of 38 acres allotted to the society in Sy No 25/2 of Pet Basheerabad Resolution 5: The BoD explained to members about the efforts being made to convince Hon'ble Chief Minister K Chandrasekhar Rao garu to handover the possession of remaining 38 acres to the society. The Chief Minister has assured that he would take the decision once the ongoing case filed by the society in Supreme Court is resolved.

Subject 1: Recording heartfelt gratitude to IT and MAUD minister K T Rama Rao garu for protecting the interests of our society

Resolution 1: The BoD places on record its sincere thanks to Minister Sri K T Rama Rao garu for his timely direction to the industries, revenue and municipal authorities not to alienate 38 acres in Sy No 25/2 in Pet Basheerabad, originally allotted to our society, to any other purposes. Members turned anxious when news reports emerged that the government directed the Medchal Malkajgiri collector to handover land to construct IT towers to TSIIC.

President Kranti Kiran brought the issue to the notice of KTR who in turn directed the officials to search for another land parcel and not to touch Pet Basheerabad land allotted to us. The society in the meanwhile filed IA 22308/2021 before the Hon'ble Supreme Court which recorded the submission of CS Vaidyanathan, senior counsel representing Govt of Telangana, that state will not allot Pet Basheerabad land to anybody.

Subject 2: Noting down the Attorney General's report submitted to the Supreme Court in house sites case

Resolution 2: The Attorney General submitted a report to the Supreme Court in the house sites case and made several suggestions. The positive aspect of the note is that it did not put journalists in the list of banned categories. We however consulted the legal experts on the note and shared with our members that the AG report was suggestive in nature and we met several of the recommendations including payment of market value. We also explained to members by posting message in the official whatsapp group that as per the legal experts opinion, any law if made on the directions of the court would be implemented prospectively while our allotments dated back to 2008. We appealed to members to not get worried about the AG recommendations.
