Subject 1: Recording the Supreme Court order in IA 22308/2021 in C A No 3797/3799/2011 Resolution 1: The BoD is elated over the favourable order issued by the Supreme Court in IA 22308/2021 in C A No 3797/3799/2011 in which it clearly directed the State government to handover the remaining 38 acres in Sy No 25/2 of Pet Basheerabad and not create any third party interest. It also allowed the members to develop the lay out and raise constructions. The SC did not provide similar relief to other societies.

Subject 2: BoD records its appreciation to Chief Justice Sri N V Ramana garu for the verdict and Chief Minister K Chandrasekhar Rao garu for ensuring that the State government

Resolution 2: The BoD places its gratitude to Chief Justice Sri N V Ramana garu for referring filed additional affidavit in time. to the plight of the journalists in the country, their meagre salaries and insecurity of job. He expressed concern over our society members waiting for decades to have a roof of their own and permitted out society to develop the lay out and members to raise constructions.

The BoD places its gratitude to Chief Minister K Chandrasekhar Rao for directing the officials to file additional affidavit on August 7 in support of our IA. The state informed the SC about its intention to implement the one time benefit clause for this time and follow whatever the verdict SC gives prospectively. We thank former MP B Vinod Kumar garu also for coordinating with the government in filing the affidavit in time.

The BoD also placed its appreciation for N Vamsi Srinivas for pursuing the legal disputes in High Court and Supreme Court for more than decade and a half.

Subject 3: Raising funds from the members to meet the future expenses.

He also brought to the notice of the BoD that efforts are constantly being made to encroach land handed over to our society in Nizampet. Whenever we approached the revenue and police, they maintain that the land was already handed or er to the society and it was the society's duty to protect such valuable land cost of which runs into hundreds of crores of

Hence it was decided by the BoD to collect Rs 50,000 each only from those members who earlier paid initial land cost of Rs 2 lakh each. Members who can not pay Rs 50,000 at one go

Resolution1: The GB condoled the death of society members and reiterated its commitment to extend the same housing benefit to the nominee/legal heir of the deceased mem bers. The members entered the names of nominees with their own hand writing at the time of admission. The GB resolved that the nominee mentioned in the register will be extended the benefit. In case there was no nominee in the register, the GB resolved that spouse should be extended the benefit. If spouse is also not alive, the GB resolved to extend the benefit to the legal heir as pronounced by the statutory government authorities.

Subject 2: Conveying heartfelt gratitude to Chief Minister Sri K Chandrasekhar Rao garu for extending support to our housing society and playing crucial role in f finding solution to our long pending case in Hon'ble Supreme Court.

President Ch Kranti Kiran and Vice President Palle Ravi explained in detail various measures taken by the government at the behest of the Chief Minister including handing over possession of 32 acres in Nizampet to our society and filing affidavit in Supreme Court at a crucial juncture which paved way for resolving the long pending issue. The GB felt that the Chief Minister's timely intervention helped members and their families who expressed their gratitude to sri KCR garu.

Subject 3: Conveying heartfelt gratitude to former Chief Justice of India Sri N V Ramana garu for understanding the plight of journalists, making crucial observations on living standards in the open Court. All members are aware that the Hon'ble Supreme Court gave a ruling in favour of our society.

Resolution 3: CEO N Vamsi Srinivas explained to members the significance of the Hon'ble Supreme Court order which delinked our society case from the SLP and rest of the soicities' case is still pending in the apex court. Because of the SC order, the crucial issue of members having own site or plot also got resolved. Sub 1: Recording the demolition work taken up in Sy No 332 of Nizampet by the district revenue and HMDA authorities and court litigation.

Resolution 1: The BoD is happy to record that the government authorities concerned demolished a shed constructed by D Narendra Babu.

Narendra Babu filed cases in the High Court challenging the demolition. High Court directed District Collector to personally take up the responsibility of alloting 32 acres to our society and demarcate Narendra Babu's Ac 1.15 guntas in Sy 333 and permanently resolve the issue within Dec 15, 2022. The BoD asked Secretary/CEO Vamsi Srinivas to be vigilant and take up all necessary follow up action on protecting 32 acres handed over to our society in Nizampet.

Subject 2: Extension of the barrication work to J S Wonders Engineering and Infra Enterprises for the remaining portion of 32 acres at the same cost.

Resolution 2: The BoD in its meeting held on 26.11.2022 decided to take up barrication for the boundary portion abutting D Narendra Babu land in Sy No 333 of Nizampet on emergency basis. The price quoted by J S Wonders Engineering and Infra Enterprises per running meter is Rs 112. The agency immediately started the work.

On inquiry it was found that the rate quoted by J S Wonders Engineering and Infra Enterprises was competitive and hence BoD decided to award the contract to same agency for the rest of the 32 acres.

The quality of material used and civil works relating to erection were satisfactory. Keeping in view of emergency, the BoD decided to continue the work and place before the General Body for ratification.

Subject 3: Recording of placing the audit reports for approval of the General Body and not recording the same in the minutes by overlook

Resolution 3: The BoD noticed that though the GB approved the annual audit reports for the year 2018-2019 and 2019-2020 in its meeting held at Shilpakalavediká on 18.07.2021 the same was not recorded in the minutes.

The General Body warned them of serious action and authorise BoD to take appropriate action following due procedures as per bylaws of the society.

Subject 4: General Body to approve expenditure incurred for barrication of 32 acres in Nizampet.

Resolution 4: The General Body passed a resolution approving the expenditure incurred to barricade 32 acres belonging to our society in Sy No 332 of Nizampet. A competitive rate of Rs 112 per sq ft was fixed. Secretary Vamsi Srinivas explained to the GB that the work was awarded at a competitive rate in view of exigency as D Narendra Babu, encroacher, filed court cases and others have also been attempting to encroach the land. Final payment made to the contractor was Rs 80,90,095 including GST
